- A. Approval of Closed Session Minutes
  - 1. October 22, 2024

Before entering closed session Ms. Jett requested for the Committee to hear a request from the Coroner. Ms. Brauer asked for an additional staff member to be added to her budget. She wants to make a change in how the shifts work because the current schedule is not sustainable. This position would require an additional \$65,000-75,000 with benefits. Committee members asked how the hours were covered previously, about the increase in staff a couple years ago and if there has been an increase in workload.

Ms. Brauer shared that McLean County, a smaller county, has four more staff members than Champaign County. Ms. Jett also explained the additional work that comes from having a level one trauma center in our community. Mr. Wilson would like to see more data to backup this request.
