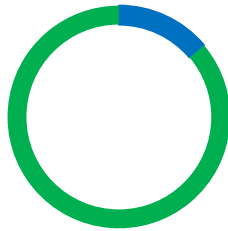

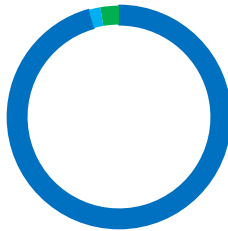
Information Dissemination to Champaign County

CCEMA had **79,139 views** of its social media content and gained an additional **277 new followers**.

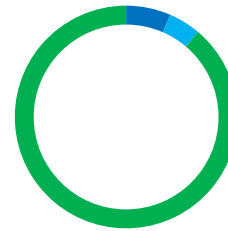
Post Views
