The County EOC has an established PPE reserve that is stored at CUPHD in case of emergency. This is a 90-day stock to support first responders and the hospitals in case of resurgence.

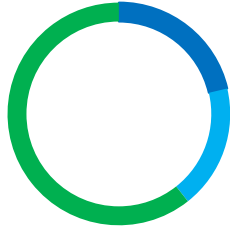

- Attended monthly homeless meeting at Salvation Army—Feb 28<sup>th</sup>

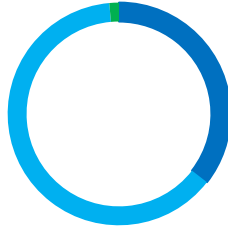
Information Dissemination to Champaign County

CCEMA had **11,533 views** of its social media content and gained an additional **323 new followers**.

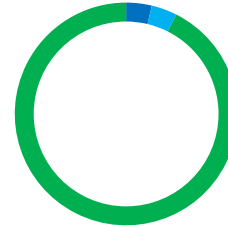
Post Views
