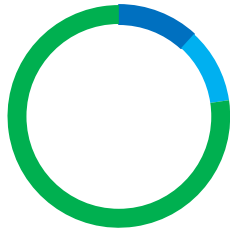
Notable Events

- Provided Emergency Management & volunteer support to Illinois Race Weekend—Apr 27-29th

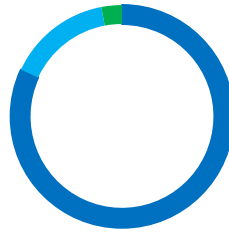
Information Dissemination to Champaign County

CCEMA had **35,151 views** of its social media content and gained an additional **285 new followers**.

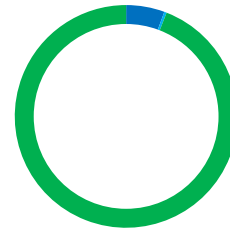
Post Views
