

SCOPE OF WORK

Project Description: Prepare deliverables to Champaign County including a PESA Report per IDOT PESA Manual, a list of PESA Findings per the BLR Manual, and Shapefiles showing any RECs and impacts to the LPA ROW during construction.

Proposed Termini:

Wilber Ave from N Market Street easterly to the end of township jurisdiction. County plans dated 6/2/2024, the improvement begins at Sta 1+19 proceeding easterly to Sta 23+90 (2,271 ft) near the railroad right-of-way line.

Scope of Work (PESA)

1. Complete Field Check / Site Reconnaissance
 - a. Waste dumping
 - b. Look for active distress areas on or along ROW lines in particular
 - c. Photos for PESA including all transformers, drums, waste piles etc.
2. Complete PESA Report
3. Submit and revise PESA Report per IDOT Comments
4. Submit Final PESA Report with PESA Findings
5. Submit PESA Shapefile to Champaign County with RECs identified and any contamination found in LPA ROW that may be encountered during construction.
6. Email Correspondence with IDOT District 5 personnel.
