

RESOLUTION NO. 3077

**A RESOLUTION ADOPTING THE
CHAMPAIGN COUNTY SOLID WASTE MANAGEMENT PLAN**

WHEREAS, the State of Illinois in adopting the "Solid Waste Planning and Recycling Act", Chapter 85, Paragraph 5951 et. seq., Ill. Rev. Stat. 1989 as amended, has mandated that counties over 100,000 population adopt solid waste management plans by March 1, 1991, and;

WHEREAS, the Act provides that any county may delegate power to a Municipal Joint Action Agency for the specific purpose of preparing the solid waste management plan, and;

WHEREAS, on November 15, 1984 the County entered into "*An Intergovernmental Agreement Between the City of Champaign, the City of Urbana, and Champaign County for the Development of a Long Range Solid Waste Plan*", providing for developing a long range plan for resource recovery and the disposal of solid waste in Champaign County and the creation of the "Intergovernmental Task Force on Solid Waste Management" ("Task Force"), and;

WHEREAS, pursuant to the recommendation of the Task Force the County, on July 22, 1986, entered into the "*Agreement and General Plan for Development of Solid Waste Disposal Facilities and Programs and the Creation of the Intergovernmental Solid Waste Disposal Association*" ("Agreement"), and;

WHEREAS, the Agreement created the "Intergovernmental Solid Waste Disposal Association" ("Association") as a Municipal Joint Action Agency pursuant to the Illinois Intergovernmental Cooperation Act, Chapter 127, Paragraph 741 et. seq., Ill. Rev. Stat. 1989 as amended, and;

WHEREAS, the Agreement grants to the Association power to "plan for such future solid waste disposal and reduction activities and facilities as may be desirable and necessary and advise the Governing Bodies of the Voting Members with respect to such plans and to implement such activities and plans to the extent approved by the Governing Bodies of the Voting Members", and;

WHEREAS, the Task Force and the Association have engaged consultants to collect information, conduct analyses and prepare reports for the purpose of developing a solid waste management plan, and;

WHEREAS, on April 18, 1989 the County Board passed Resolution No. 2843 delegating authority to prepare a solid waste management plan to the Intergovernmental Solid Waste Disposal Association, and;

WHEREAS, pursuant to County Board Resolution No. 2843 and under the authority of the Agreement the Association has prepared a plan which conforms to the waste management hierarchy established as State policy in subsection (L) of Section (2) of the Illinois Solid Waste Management Act, Chapter 111 1/2, paragraph 7052, Ill. Rev. Stat. 1989, and;

WHEREAS, in preparing the plan the Association took the following actions:

- (1) formed the Board Advisory Committee to review the plan during its preparation; makes suggestions and propose changes to the plan including representatives from municipalities, citizen organizations, industry, the private solid waste management industry, local recyclers and other persons;
- (2) provided written notice to all municipalities and interested members of the public when development of the plan began;
- (3) submitted copies of the plan to the Illinois Environmental Protection Agency, all municipalities within the County, and to the Champaign County Regional Planning Commission; made the proposed plan available for review and comment during a period commencing October 13, 1990 and ending January 14, 1991;
- (5) conducted a public hearing on the plan on December 5, 1990;
- (6) submitted to the County along with the final plan a document containing written responses to substantive comments made during the comment period, and;

WHEREAS, the plan prepared by the Association includes:

A description of the origin, content and weight of municipal waste currently generated within the County's boundaries, and the origin, content, and weight of municipal waste that will be generated within the County's boundaries during the next 20 years, including an assessment of the primary variables affecting this estimate and the extent to which they can reasonably be expected to occur;

A description of the facilities where municipal waste is currently being processed or disposed of and the remaining

- available permitted capacity of such facilities;
- (3) A description of the facilities and programs that are proposed for the management of municipal waste generated within the County's boundaries during the next 20 years, including their size, expected cost and financing method;
 - (4) An evaluation of the environmental, energy, life cycle cost and economic advantages and disadvantages of the proposed waste management facilities and programs;
 - (5) A description of the time schedule for the development and operation of the proposed facility or program;
 - (6) The identity of potential sites within the County where the proposed waste processing, disposal and recycling programs will be located and an explanation of how the sites will be chosen, and;
The identity of the governmental entity that will be responsible for implementing the plan on behalf of the County and an explanation of the legal basis for the entity's authority to do so, and;

WHEREAS, the plan contains provisions for a recycling program including:

- (1) provisions for its implementation throughout the County;
- (2) a time schedule for implementation;
- (3) designation of a recycling coordinator;
- (4) a design intended to recycle 43% by weight of the municipal waste in the third and fifth years of the program;
- (5) public education and promotion programs;
- (6) provisions for compliance including incentives and penalties if recycling rates are not maintained by voluntary programs;
- (7) provisions for recycling collected materials;
- (8) identifying potential markets for materials collected;
- (9) promoting the use of products made from recovered or recycled materials among businesses, newspapers and local governments, and;
a call for ways to implement economic incentives, to encourage recycling, including, but not limited to volume based pricing, and;

WHEREAS, major components of the solid waste management system envisioned in the plan have already implemented or are in the process of being implemented, and;

WHEREAS, the Association made a presentation of the general contents of the plan to a Special Study Session of the County Board on January 24, 1991, and;

WHEREAS, the plan has been received at the Champaign County Board Office on February 19, 1991 and submitted to the County Board for approval.

NOW, THEREFORE, BE IT RESOLVED, by the Champaign County Board, Champaign County, Illinois, as follows:

1. That the Solid Waste Management Plan as forwarded by the Board of the Intergovernmental Solid Waste Disposal Association on January 30, 1991 and received in the County Board Office on February 19, 1991 is hereby adopted as the Champaign County Solid Waste Management Plan subject to the following changes:

A. Amend Paragraph (1), page 135, under the Heading "Residential" in Section III, Recycling to read as follows:

(1) The Cities and the County should institute where feasible, a system of volume based pricing of solid waste services. The economic incentives are intended to encourage source reduction and recycling. To identify the appropriate incentives, the implementing agency should identify a variety of options for doing so with input from, at a minimum, the following groups:

- a) local government
- b) private haulers
- c) citizen organizations
- d) curbside recycling service providers, and
- e) local environmental groups

A report identifying which options would be best for the County, should be presented to the implementing agency's Board or Council within 1 year of the plan's adoption. Additional time may be granted if pilot programs are undertaken as part of the study. The report should also include exact wording for any

ordinances, or changes to local government policies, if necessary.

- B. Add a new recommended goal (7) under the Heading "Long-Term Goals and Recommendations" in Section III, Recycling to read as follows:

(7) Sixty percent (60%) of the County's total solid waste should be diverted from the landfill by the year 2000.

2. That the Intergovernmental Solid Waste Disposal Association is hereby directed to take such actions as may be necessary and desirable to implement and review the Champaign County Solid Waste Management Plan subject to the provisions of the *"Agreement and General Plan for Development of Solid Waste Disposal Facilities and Programs and the Creation of the Intergovernmental Solid Waste Disposal Association."*


3. That the Manager of the Intergovernmental Solid Waste Disposal Association is hereby directed to submit a copy of the Champaign County Solid Waste Management Plan along with a certified copy of this resolution to the Illinois Environmental Protection Agency by March 1, 1991.
