Case Synopsis: On Monday (04/22/24) at approximately 2217 hrs, a Champaign County Deputy Sheriff and canine handler conducted a routine traffic stop in the city of Urbana. During the traffic stop, the deputy utilized a state certified narcotics detection canine, to screen the exterior of the vehicle involved for the presence of illegal drug odor (s). During the traffic stop, a probable cause search of the violator vehicle was conducted, after the canine alerted to the presence of illegal drug odors emanating from the vehicle. That search yielded a small amount of suspected methamphetamine. The driver was placed under arrest for the possession of a controlled substance and transported to the Champaign County Satellite Jail. He was later issued citations for driving on a revoked drivers license, operating an uninsured motor vehicle, and for his stopping, standing, or parking in a prohibited area (crosswalk).
