The Animal Control Department has seen no significant changes for the month of October. The staff levels have remained the same and the number of animals impounded in October is at normal levels for this time of year. We held a rabies vaccination clinic on October 21st. We were able to provide 154 rabies vaccinations at no cost to Champaign County citizens. The U of I Shelter Medicine club provided the vaccinations at no cost. This was held to celebrate World Rabies Day.
