RESOLUTION 2024-179

RESOLUTON PLACING AN AMENDED QUESTION TO ELIMINATE THE OFFICE OF THE COUNTY AUDITOR ON THE NOVEMBER 5, 2024, GENERAL ELECTION BALLOT

WHEREAS, Article VII, Section 4 of the Illinois Constitution provides that the office of auditor may be eliminated, and the terms of office and manner of selection changed by countywide referendum; and

WHEREAS, Pursuant to 10 ILCS 5/28-7, any such public question may be initiated by the Champaign County Board by resolution requesting the submission of the proposal for such action to the voters of the governmental unit at a regular election; and

WHEREAS, if the office of auditor is eliminated, the Champaign County Board will transfer the functions of such office to a newly created Finance Department, working with the County's external auditor; and

WHEREAS, the Champaign County Board deems the question of whether the County Auditor's function shall be performed by an elected official is a question best answered through public deliberation and the ultimate determination of the electors of Champaign County; and

WHEREAS, Resolution 2024-178 was passed by the Champaign County Board on July 18th, 2024, with the following language: ELIMINATE THE OFFICE OF COUNTY AUDITOR, Shall the elected office of the Champaign County Auditor be eliminated, effective December 1, 2024 as the County utilizes the statutorily required external auditor and this will be a cost savings of approximately \$150,000?

NOW, THEREFORE, BE IT RESOLVED, the Champaign County Board hereby rescinds Resolution No. 2024-178; hereby passes this Resolution No. 2024-179 in replacement of Resolution No. 2024-178; and hereby directs the County Clerk to use the language printed below for the ballot referendum question.

BE IT FURTHER RESOLVED by the County Board of Champaign County that the following question shall be submitted to the voters and placed on the November 5, 2024, General Election ballot:
