- We are located in Champaign County. There are 30 townships in our county.
- Our township encompasses the Villages of Ludlow and Rantoul (north end), and surrounding rural area.
- The population of our Township is 4,077 as of the 2020 census.
- We have one employee of the Township (excluding elected officials).
- Ludlow Township receives on average seven applications monthly for General
 Assistance and assists four residents on average each month.
- 2023 Annual Township Budget: Town \$178,450; General Assistance \$117,400;
 Cemetery \$33,900. Total Budget \$329,750.
- Our Road District has one full time employee, and several part time, as needed (excluding elected officials).
- 2023 Annual Road District Budget: General Road \$267,900; Permanent Road \$225,900; Joint Bridge \$40,000. Total Budget \$533,800
- Ludlow Township Road District maintains 59 miles of roads.
- Our Township's equalized assessed valuation for 2023 is \$78,272,182.
- Ludlow Township provides for and maintains Ludlow Township Cemetery.

Studies on local government efficiency show that:

- The average local government in Illinois serves 1800 residents, compared to our township which serves over 4,000 residents.
- Most townships in Illinois have no bonded indebtedness. Ludlow Township does not have any debt.
- Together with road districts they are an integral element of local democracy. Township expenditures have grown at a lower rate than those of any other level of government since 1992.
- Townships have lower labor costs and employ mostly part time employees. This is true of Ludlow Township.
