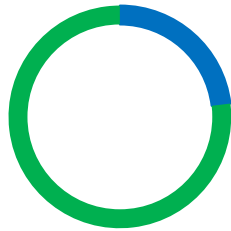

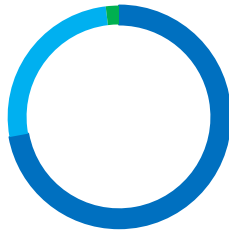
Information Dissemination to Champaign County

CCEMA had **20,035 views** of its social media content and gained an additional **606 new followers**.

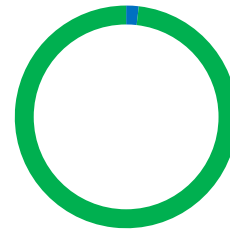
Post Views
