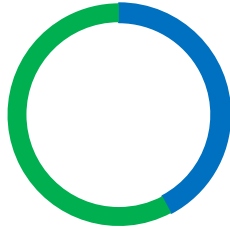

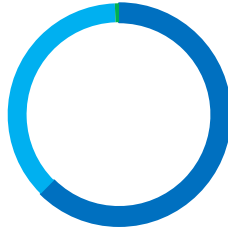
Information Dissemination to Champaign County

CCEMA had **24,016 views** of its social media content and gained an additional **798 new followers**.

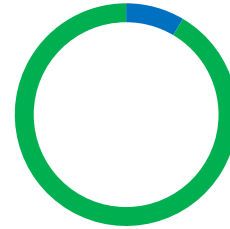
Post Views
