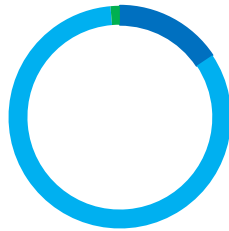

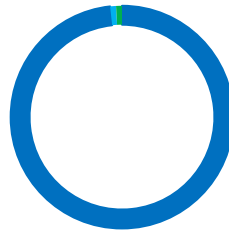
Information Dissemination to Champaign County

CCEMA had **12,447 views** of its social media content and gained an additional **551 new followers**.

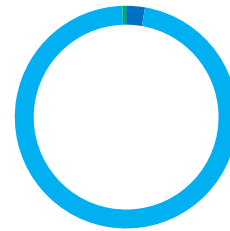
Post Views
