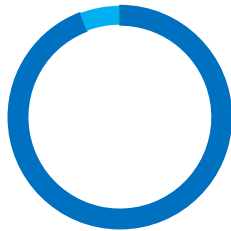

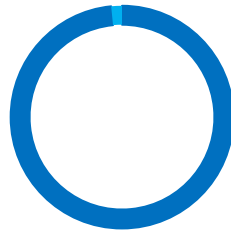
Information Dissemination to Champaign County

CCEMA had **166,127 views** of its social media content and gained an additional **479 new followers**.

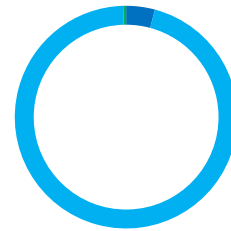
Post Views
