EQUIPMENT DESCRIPTION: LAZERS EDGE OFFICE AUTOMATION, INC. agrees to maintain the equipment and features (herein called "EQUIPMENT") listed in addendum B, in accordance with the following terms and conditions;

EQUIPMENT LOCATION: Same as above address **YES;** if equipment is at other location specify:

PAYMENT: The method of payment for the maintenance agreement will be made as SPECIFIED IN ADDENDUM A. The fee for this contract will be in accordance with addendum A. Addendum A may contain additional services and equipment that LAZERS EDGE OFFICE AUTOMATION, INC. has agreed to beyond those in this agreement and may contain conditions that the CUSTOMER must meet. Addendum A is an integral part of the agreement and is part of this agreement by reference and or attachment.

CHARGES: The following services or repairs are considered to be NON-STANDARD SERVICE, which will be provided at CUSTOMER'S expense, based on LAZERS EDGE OFFICE AUTOMATION, INC.'S then current rates:

(1) Repair or replacement of Equipment damaged by accident, fire, theft, power failure, abuse, unsuitable environmental conditions, Customer's attempt to repair or modify the Equipment, operational errors, or other circumstances not under the control of LAZERS EDGE OFFICE AUTOMATION, INC.

(2) Service provided at Customer's request outside the Principal Period of Maintenance.

(3) Service provided to equipment moved to locations other than the specified locations in this agreement.

(4) Service required due to inadequate facilities on site or by the failure of equipment or system other than the Equipment, including without limitation that furnished by the telephone companies, by the power company, or by other vendors of equipment.

In the case of items (2) and (3), the additional charges are indicated in a document entitled "Terms of Non-Standard Service" which will be made available to Customer on request. The Terms of Non-Standard Service may be revised by LAZERS EDGE OFFICE AUTOMATION, INC. from time to time. Customer shall pay any taxes imposed with respect to this Agreement of the services provided hereunder. The Service Charges shall be payable thirty (30) days after the date of the respective invoice. A late charge of five percent (5%) of the payment will be assessed on past due amounts and/or at LAZERS EDGE OFFICE AUTOMATION'S INC. option, cancellation of this agreement.

ALTERATIONS AND ATTACHMENTS: Alterations in or attachments to the Equipment may be made only with the prior written consent of LAZERS EDGE OFFICE AUTOMATION, INC.. If any alterations or attachment interferes with the normal and satisfactory operation or maintenance of the Equipment in a manner which increases substantially the costs of maintenance thereof or creates a safety hazard, Customer will, notify LAZERS EDGE OFFICE AUTOMATION, INC. to that effect, and at the option of LAZERS EDGE OFFICE AUTOMATION, INC., promptly remove the alterations or attachment and restore the Equipment to its original condition, or have the alteration or attachment appended to this agreement with appropriate charges.

WARRANTY: LAZERS EDGE OFFICE AUTOMATION, INC. will make all necessary adjustments, repairs, and replacements necessary to maintain the Equipment in good working order. LAZERS EDGE OFFICE AUTOMATION, INC.'S obligations under this warranty are limited to the repair and labor, and to maintenance as set forth herein. The warranty set forth above shall not apply to any Equipment if any person other than LAZERS EDGE OFFICE AUTOMATION, INC.'S field service engineer, or other person authorized by LAZERS EDGE OFFICE AUTOMATION, INC., without LAZERS EDGE OFFICE AUTOMATION, INC.'S consent, modifies, adjusts, or repairs such Unit or performs any maintenance service on it. EXCEPT FOR THE EXPRESS WARRANTIES STATED ABOVE, LAZERS EDGE OFFICE AUTOMATION, INC. DISCLAIMS ALL WARRANTIES WITH REGARD TO THE SERVICES FURNISHED UNDER THIS AGREEMENT, INCLUDING ALL IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS, AND THE EXPRESS WARRANTIES STATED HEREIN ARE IN LIEU OF ALL OBLIGATIONS OR LIABILITY ON THE PART OF LAZERS EDGE OFFICE AUTOMATION, INC. FOR DAMAGES, INCLUDING BUT NOT LIMITED TO CONSEQUENTIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH THE USE OR PERFORMANCE OF THE EQUIPMENT.

RELOCATIONS: Upon written request by Customer, LAZERS EDGE OFFICE AUTOMATION, INC. agrees to provide, at Customer's expense, equipment removal or relocation service at LAZERS EDGE OFFICE AUTOMATION, INC.'S then current rates.

ASSIGNMENT: Without prior written consent from LAZERS EDGE OFFICE AUTOMATION, INC., Customer will not assign or transfer this agreement

LIMITATION OF LIABILITY: LAZERS EDGE OFFICE AUTOMATION, INC., will not be liable for any indirect, special, or consequential damages in connection with or arising out of services provided for in this Agreement, nor will LAZERS EDGE OFFICE AUTOMATION, INC., be liable for any failure or delay in performance hereunder which is due, in whole or in part, to any cause beyond its control. Any terms and conditions or any purchase order or other instrument issued by Customer in connection with this Agreement which are in addition to or inconsistent with the terms and conditions of the Agreement will not be binding on LAZERS EDGE OFFICE AUTOMATION, INC., and will not modify this Agreement.

ENTIRE AGREEMENT: The entire Agreement between the parties with respect to the subject matter hereof is contained in the Agreement. There are no understandings, agreements, representations, or warranties, expressed or implied, not specified herein.

GENERAL: The Agreement shall not be deemed or construed to be waived, amended, rescinded, canceled, or modified in whole or in part by either party unless such waiver, amendment, rescission, cancellations, or modification is in writing, signed by both parties hereto.

LAZERS EDGE OFFICE AUTOMATION, INC., reserves the right to assign this agreement to other parties in order to fulfill all warranties and obligations expressed herein.

The laws of the State of Illinois shall govern this Agreement. The terms, warranties and agreements contained herein shall bind and inure to the benefit of the parties hereto and their legal representatives, successors and assigns.

TERMS: This agreement shall remain in force, except as otherwise provided, for a period of 365 days from the EFFECTIVE DATE.

MAINTENANCE SERVICE: The service, which will include preventive and remedial maintenance, spare parts and component replacements on an exchange basis as required, shall be such as to keep the Equipment in good working order and in accordance with established Equipment Operating Specifications. CUSTOMER will provide LAZERS EDGE OFFICE AUTOMATION, INC. with reasonable access to the Equipment to enable LAZERS EDGE OFFICE AUTOMATION, INC. to discharge its responsibilities hereunder. Service shall be available only during the "Principal Period of Maintenance" (i.e. 8:30 a. m. to 5:00 p. m. local time, Monday through Friday, excluding LAZERS EDGE OFFICE AUTOMATION, INC. - observed holidays), unless it is otherwise specified in the Equipment(s) Order(s). This agreement shall also include all TONER CARTRIDGES. LAZERS EDGE OFFICE AUTOMATION, INC. herein states that it shall use remanufactured, and new toner cartridges at its sole option. If during the term of this agreement, the CUSTOMER wishes to use new toner cartridges exclusively an additional rate of .0246 per copy will be charged and CUSTOMER herein agrees. **IN EFFECT, THIS AGREEMENT COVERS ALL LABOR, PREVENTIVE MAINTENANCE, AND TONER CARTRIDGES THAT WILL BE NECESSARY TO MAKE THE PRESCRIBED NUMBER OF COPIES**, subject only to the terms and conditions stated in the service agreement.
