Case Synopsis: On Friday (06/21/24) at approximately 2327 hrs, a Champaign County Deputy Sheriff conducted a routine traffic stop in the city of Champaign. A search of the vehicle yielded a small amount of suspected cannabis and cannabis wax. The driver and passenger both admitted to possessing cannabis and cannabis wax at that time. They were each issued a citation for the illegal transportation of adult use cannabis in a motor vehicle and the driver was issued a citation for speeding (35+) as well. Both occupants were released at the conclusion of this incident.

Case Synopsis: During the afternoon of July 10, 2024, Champaign County Sheriff's Deputies conducted a traffic stop in the 500 block of S Duncan Road for a violation of the Illinois Vehicle Code. During the investigation, deputies developed probable cause to believe the vehicle contained illegal drugs. When deputies asked the driver to step out so they could conduct a search of the vehicle the driver fled in the vehicle. During the pursuit, the driver threw a large bag out of the passenger window. After a brief pursuit the driver was apprehended. The vehicle and bag were subsequently searched and over 500 grams of suspected Cannabis was found and seized. The vehicle was towed and held for forfeiture. The driver was arrested and transported to the Champaign County jail where he was booked for operating a vehicle while registration suspended.
