<p>Case Synopsis: On Saturday (08/03/24) at approximately 0050 hrs, a Champaign County Deputy Sheriff conducted a traffic stop on a vehicle in Champaign, after observing the vehicle to be crossing over the center dotted line of the roadway consistently, without making a lane change. This occurred just after a reporting party had called into 911 and stated that his child's mother had been driving while intoxicated. During the traffic stop, the driver displayed signs of impairment and admitted to consuming alcohol prior to operating her motor vehicle. She was placed under arrest at the conclusion of the stop, for driving under the influence of alcohol. The female driver was then transported to the Champaign County Satellite Jail for her offense.</p>

Case Synopsis: On Sunday (08/18/24) at approximately 1436 hrs, a Champaign County Deputy Sheriff conducted a subject stop in the city of Champaign, after observing a driver of a vehicle that was known to have a revoked Illinois driver's license. Once the vehicle was stopped, it was confirmed that the driver had been the registered owner of the vehicle and that he did possess a revoked driver's license at that time. The driver was later released after citations were issued to him and his vehicle was towed from the scene. The vehicle was subject to seizure in this incident, due to the driver knowingly operating his motor vehicle while having a revoked driver's license and as his driver's license had been revoked for previously driving under the influence of alcohol.
