Case Synopsis: On July 25th, 2024, Deputies responded to the 2500 block of Roland Drive in Champaign Twp in reference to a physical altercation between neighbors. It was advised that a neighbor arrived at the reporting party's home and battered her and that the issue stemmed from the suspect's child running into the street and nearly hitting the vehicle of the reporting party's mother.
