Case Synopsis: On Saturday (09/14/24) at approximately 1425 hrs, a Champaign County Deputy Sheriff conducted a routine traffic stop in the Urbana Township, after observing a vehicle that displayed suspended plates/registration. During this incident, the driver and front seat passenger attempted to exit the vehicle and leave on foot. They returned to the vehicle after being ordered to do so. While making contact with the occupants of the vehicle, the deputy asked the driver to roll down the rear driver side window of the vehicle, due to its' heavy window tint. The rear seat passenger prevented his window from being rolled down, refused to exit the vehicle when ordered to do so, and resisted deputies while they attempted to remove him from the vehicle and detain him in handcuffs. The male was found to have several warrants for his arrest and was transported to the Champaign County Satellite Jail. The female driver was later released after citations were issued to her.
