Case Synopsis: On Saturday (09/28/24) at approximately 2235 hrs, a Champaign County Deputy Sheriff and canine handler conducted a routine traffic stop in the Saint Joseph Township. This occurred after the deputy had observed a pickup truck pulling a vehicle trailer that displayed non-operational lights, as well as having no rear registration plate displayed on the trailer. During this incident, the driver had been the registered owner of the vehicle involved and had been operating his pickup truck with a suspended Illinois driver's license. While on scene of the traffic stop, a narcotics detection canine was utilized to screen the exterior of the vehicle for the presence of illegal drug odor (s). Following a positive alert provided by the narcotics canine, a search was conducted of the vehicle and its' occupants. A significant amount of suspected methamphetamine was later seized, as well as suspected crack cocaine and heroin. The vehicle's occupants were released at the conclusion of this incident, after being issued Notice to Appear for their criminal offenses. The vehicle was later removed from the roadway by a local towing service.
