Case Synopsis: On 09/24/2024 Deputies observed a vehicle commit an IVC violation in the 1400 block of Dobbins Dr. located in Champaign Township. Deputies attempted to initiate a traffic stop on the vehicle, but the driver refused to pull over. While attempting to stop the vehicle, the suspect driver exceeded the speed limit by +20 mph multiple times and disobeyed 6 traffic control devices. The pursuit ended with the driver crashing their vehicle into the curb of the roadway which disabled the vehicle. The driver fled the scene on foot and was apprehended shortly after police officers from the Champaign Police Department a few blocks away. It was also learned that the front seat passenger had a valid warrant for her arrest. The driver was arrested for Aggravated fleeing and eluding a police officer and resisting/obstructing a police officer. The driver was also issued multiple citations. The driver is currently out on pre-trial release for other charges. No one was injured.
