Upon arrival, Deputies were met by the reporting person who stated his girlfriend would not let him into the residence to gather his belongings. The female half stated the male had broken her phone and she did not want to allow him into their residence until he pays for the broken phone. The male half would later attempt to force entry into his residence but was unsuccessful. Due to statements made by the female half and the presence of children, Deputies would conduct a standby while, both parties became increasingly verbal. The male half scattered belongings around the house. It was discovered, the specific item the male half was looking for had been hidden by the female. After it was located, Deputies were able to retrieve the property and the male half left. A report has been filed with the Department of Children and Family Services (DCFS).
