ACTION ITEMS/DISCUSSION

Sheriff Heuerman advised the trial period with the National Testing Network (NTN) has expired and he would like to continue with this form of testing. He spoke with the Commission about the recent joint testing for Deputy Sheriff with the Urbana Police Department. A total of 33 individuals took the test. Sheriff went on to talk about we are hurting for individuals to take the Correctional Officer exam. He asked the Commission to amend the time individuals can retake the test from one year to 90 days for all positions. Commissioner Cunningham moved to change the number of days an individual can retest to 90 days, seconded by Commissioner Clark; motion passed.

OTHER BUSINESS

Sheriff Heuerman advised the Commission the Law Enforcement Sergeant promotion listing will expire in June. He will be seeking sergeant applicants soon due to an anticipated retirement.

Motion to adjourn the meeting by Commissioner Clark; seconded by Chair Cunningham. The meeting adjourned at 3:09 p.m.
