

Champaign County Veteran Assistance Commission Meeting Minutes

1. Call to Order

Board President Timothy T. Tyler called the meeting to order at 6:00 PM.

2. Pledge of Allegiance

The Pledge of Allegiance was recited.

3. Roll Call

4. Introduction of Guests/First Attendees

No first-time guests or attendees were present.

5. Approval of July 2025 Board Meeting Minutes

- Motion to approve: David Murphy

- Motion passed unanimously.



6. Public Comments

- Jeff Wilson offered birthday wishes to the United States Air Force, recognizing its anniversary.
- David Murphy raised concerns regarding emergency funding for eviction cases involving families with small children. Superintendent Walker noted a rise in eviction requests and detailed a September case involving a \$2,665 eviction notice where the family included small children. Emergency funding was used to keep families housed.

7. Superintendent Report

Superintendent Cheryl Walker presented the monthly report:

- Calls/Emails: 121 phone calls, 122 emails, 35 office visits.
- Funding Assistance: \$9,636 distributed, including rent (\$1,900), mortgage (\$851), utilities (\$4,135), and emergency funds (\$2,750). A total of 32 veterans were assisted.
- Claims/Records: 3 VA claims, 1 VA application, 1 burial, 2 DD-214s, and medical record requests.
- Events/Training: Attended two veteran organization meetings, supported the Homeless Veteran Stand Down on September 6, and completed trip training.
- Memorial Wall: A county employee's lawn care equipment damaged the Veterans
 Memorial Wall. Superintendent Walker documented the damage and will follow guidance
 from Jeff Wilson to write a formal letter to the Acting Facilities Director requesting
 repair. Additional maintenance issues (railings, power washing, poison ivy, rust) were
 also noted.

8. Treasurer's Report

Superintendent Walker provided an overview of the Treasurer's Report:

- Line-item spending was reviewed; major client assistance funds included rent (\$23,413.34 remaining), utilities (\$23,025.90 remaining), and software/licensing (61% spent).
- Office supplies, equipment under \$5,000, and postage were also reported.
- Recommendation was made to include repair of flags and memorial upkeep in upcoming expenditures.
- Motion to approve Treasurer's Report: David Murphy
- Second: Mattie Gray
- Motion passed unanimously



9. Unfinished Business

 Bylaws: David Murphy proposed additions to bylaw language regarding Treasurer's duties. Language was included in board packets for review. Motion passed to adopt the revisions into CCVAC bylaws

10. Fiscal Year 2026 Budget

- Discussion noted county-level hesitation on approving budget items and a potential across-the-board cut (3–6%).
- The FY26 budget was deferred until September 30, 2025, when county finance decisions would be finalized.
- Action: Fiscal Year 2026 budget vote postponed until November 19, 2025, meeting

11. New Business

- a. Hiring of New Administrative Assistant
 - Superintendent Walker explained delays due to county-level approval processes. A candidate has been identified, but the position has not yet been posted due to concerns about funding availability. The board reiterated support for hiring, with emphasis on completing required paperwork and resubmitting it to Finance.
 - Motion made to proceed with the hiring process pending county approval. Motion passed

12. Good of the Commission

- Discussion on creating a community calendar to track veteran-related events.

 - o December 7, 2025: Pearl Harbor Day Ceremony at Lincoln Square Mall.
- Proposal for CCVAC to take leadership of the Homeless Veterans Stand Down beginning in September 2026.
- Suggestion for board members to purchase uniform polo shirts with CCVAC insignia to promote unity and recognition at community events
